If people don't meet their mutual obligation requirements their payments may be suspended or cancelled. EJA believes this system should be abolished. It has been administered unfairly, and sometimes unlawfully. This has resulted in significant harm, particularly when people's payments have been cancelled or suspended, their mutual obligations are too onerous or unsuitable as they only have a partial capacity to work, and when requirements have interfered with people's ability to search for work and participate
